The supervisors of the Broad River Soil and Water Conservation District met a total of 10 times in regular session during the fiscal year. Wheatley served as Chairman, C. Andrews served as Vice-Chairman, Yeany served as Treasurer, and C. Brown served as Chaplin.

The District held their Annual Affiliate Member Meeting on November 13, 2012 at the Union Baptist Church in Hull, GA. Dinner was prepared and served by the Franklin County FFA group and approximately 85 were in attendance. The District and Georgia Ag Credit presented the Moore family with the Farm Family of the Year Award and a check for \$1000.

The District was awarded a \$20,000 grant from USDA to promote conservation program outreach.

The District reviewed and ratified 2 erosion sedimentation and pollution control plans.

The District ordered and distributed Soil Stewardship materials.

The District sponsored students to attend the NRCW in Tifton, GA.

The District supported multiple 319 grants through Oconee River RC&D, Chestatee-Chattahoochee RC&D, and Central Savannah RC&D.

The District supported the rehabilitation of the Watershed Structures South River #29.

The District submitted applications for 5 Partners For Fish and Wildlife Projects.

The District held a Small Farm Conference at Unicoi State Park in Helen, Georgia on June 20-21, 2013.
