Chairman Martin asked for approval of the minutes from the October 10, 2023 meeting. There was a motion by Vikki Consiglio to approve the minutes, a second by Edwin Nix, and the motion carried to unanimous approval

<u>Executive Director's Report</u> — Mitch Attaway was unavailable so Robert Amos gave the Director's Report. Mr. Amos stated there is no old business. Mr. Amos stated

there are 3 incoming employees, Devekio Terrell, Lindy Bates and Serena Shopes, in the Athens office with 1 position still available. He stated there are 2 outgoing employees, Alexandra Chesna and Abigail Foster, in the Athens Office. We hate to lose them. He stated the financial report is in the packet, if you have any questions he will try to answer the questions. Chairman Martin asked when the fiscal year ends. Mr. Amos stated June 30. Mr. Amos stated that Mr. Attaway did not give him anything else to go over.

<u>Conservation Report</u> —Mr. Amos stated that there are 44 supervisors that need to be approved by the board and 1 resignation Mr. Larry G. Williams from the Coosa River SWCD. Chairman Martin called for a motion on the appointments and resignation. Vikki Consiglio made a motion to approve the appointments and resignation, a second by Edwin Nix and the motion carried to unanimous approval.

<u>Urban Report</u>—Ben Ruzowicz stated there have been 650 plans reviewed since the last meeting. Mr. Ruzowicz stated there have been 233 courses, with 880 recertifications and 740 new certifications. We are averaging 700 to 800 coming into the program each month. Mr. Ruzowicz stated that other states like Tennessee are starting to accept Georgia's certification.

Rural Report: Mr. Ben Hyer gave the report. See the attached report.

<u>Public Comment:</u> Danny Hogan stated there has been a problem getting money out when we have voted to send funds to an entity. It seems that it never gets there. He stated that he has had 3 entities contact him lately. Bleckley County asked for funds this year but also stated they had not received their funds from last year. He stated he is not sure what the technique is to get money sent out but he hopes you all will discuss this and figure out where the breakdown is. He was told by a representative to start at the top and work down. This is where government gets a bad reputation. He stated that when they vote to send funds out, we would like to see the funds go out within 30 to 60 days. That should be enough time. He stated he is sure there are some entities that never got their money but they never came back to us.
