The Board of Supervisors usually meet the second Thursday of every month. The meeting locations are rotated within the counties of the District. All Board members voluntarily give up their time to promote and encourage soil and water conservation. Representatives from agricultural agencies, state and federal governments, farmers, and businessmen attend these monthly meetings to discuss the district's needs and problems. Any interested individuals are encouraged to attend. The goals of the Brier Creek District are to use each acre of land within its capabilities and to treat each acre according to its need. The District assists landowners and users in planning and applying needed conservation treatment in soil, water, woodland, wildlife and natural resources, so that present and future generations may continue to enjoy the blessings of the good earth.

#### **DISTRICT ACTIVITIES**

- 1. Maintained and reviewed all Memorandums of Understandings and Memorandum of Agreements with partnering agencies and enlisted their assistance in the District's program, activities, and events.
- 2. Cooperated with other Districts to be informed of statewide activities.
- 3. Reviewed erosion and sediment control plans as required by the Erosion and Sedimentation Act of 1975.
- 4. Sponsored five students from the District to attend the Natural Resource Conservation Workshop held June 3rd through June 7th at ABAC College in Tifton, GA.
- 5. Entered into agreements with owners or land managers to furnish technical assistance in developing a sound conservation plan and assisted in applying needed conservation practices.
- 6. District proved financial support to assist in the cost of the GACDS Annual Meeting held in Braselton, GA and encouraged supervisor participation.
- 7. Promoted and sponsored Soil and Water Stewardship Week activities April 29th through May 6th.
- 8. Utilized media outlets to informed the public of District activities, programs and events.
- 9. Maintained two no-till drill rental units for use by landowners through a cooperative effort with the Central Savannah **River RC&D Council.**
- 10. Developed budget for FY 13 using Committees for each category.
- 11. The District provided support and information to groups and organizations on the Georgia Comprehensive Water Plan and the Savannah-Upper Ogeechee Regional Water Council's regional plan.
- 12. Presented conservation programs to Civic Clubs.
- 13. Hosted a Conservation Easement Workshop in partnership with the Central Savannah River Land Trust.

#### NO-TILL DRILLS AVAILABLE
