ROLES & PARTNERSHIPS:

Georgia Soil and Water Conservation Commission -

GSWCC is a non-regulatory Georgia State Government agency dedicated to protect, conserve, and improve soil and water resources. Due to additional funding, regional offices were able to be reimplemented in 2023.

Region II covers the districts listed at the top of this newsletter and their office is located at 4310 Lexington Rd., Athens. Regional staff provide technical support and guidance to SWCDs, Local Issuing Authorities, and community members with concerns about soil and water quality.

In conjunction with our Urban Lands Department, we have conducted three overviews for local cities and counties. These overviews are designed to help the municipalities address and proactively tackle any issues they may be having with erosion and sediment control from land disturbing activities. We continue to work with citizens that notice issues in their area and pass along our reports to the governing entity or GA EPD.
