### Work Plan for Fiscal Year 2022

The Towaliga Soil & Water Conservation District, as required by Georgia law (OCGA 2-6-33), is charged with creating a plan of work for each fiscal year. This plan of work will lay out activities and events that the District plans to carry out in order to advance its mission to protect the natural resources and serve the citizens within the District.

#### 1. NATURAL RESOURCE CONSERVATION – TOURS AND FIELD DAYS

Sponsor and conduct demonstrations, tours, and field days to acquaint farmers and land-users with methods of protecting soil and water resources and promote greater participation and compliance with best management practices. When necessary, seek outside financial resources to support these events.
